Accomplishments

- 1. Continue to maintain the community areas and allow asset growth relative to our revenue and adopted fiscal budget.
 - a. PRC 4291 Vegetation clearance at clubhouse
 - b. A new water heater and pressure tank were replaced in the clubhouse and a second water filter was added.
 - c. Two new toilets were installed in the clubhouse

 - a. Several complaints from homeowners have been addressed through cease and desist letters to the homeowner in violation of our CC&R's and Rules and Regulations. The county has also been notified of any violations which fall under county regulations.
